## How does the Family Membership Dues program work?

The first family member (head of the household) is required to pay the full International Dues and entrance fee.

Up to four more subsequent qualifying family members over the age of majority in the same household and the same club shall pay one half (50%) of the standard annual dues and no association entrance fees.
